Visible thermal system insulation (TSI) has been removed in the 1999 remodel project. Suspect asbestos-containing pipe insulation may continue to exist in hidden cavities. All non-friable materials observed, such as sheet flooring/mastic, floor tile, cove base/mastic, gypsum wallboard, plasters, chalkboards, window glazing, electrical wiring, etc. were in good condition.
