Long Range Planning Committee Meeting

1. Call to Order: 6:05 pm
2. LRPC Meeting Minutes
 - a. A motion was called to approve the 10-16-24 LRPC meeting minutes.
The meeting minutes were approved with no adjustments.
3. Update on the Small Schools Task Force (SSTF)
 - a. The SSTF has held six meetings, with two more expected.
 - b. Five community engagement forums have occurred, as well as a town hall style meeting. This portion is complete.
 - c. A member highlighted the FAQ page on the district website, providing a useful tool for the community to obtain information in response to questions submitted through the portal, located on the SSTF information page <https://www.wlww.k12.or.us/Page/17358>. Additional documents requested by the SSTF are posted there as well.
 - d. Members were encouraged to forward questions from the community to

the Communications Director or LRPC district staff.

4. Review Update to Long Range Facilities Plan (LRFP) - Part I the Long Range Plan (LRP) - with Rebecca Stuecker from Arcadis
 - a. Section A: Framework for Excellence. Describes the District's vision, values, and educational needs as the basis for facility planning and operational decisions, including:
 - i. Updates on current educational programs
 - ii. New programs, including Mentoring and Affinity Groups, the Family Empowerment Center (FEC), the Heumann Center, and Hybrid Learning Options
 - b. Section B: School Facilities. Identifies facility needs based on school capacities, enrollment, and forecasted growth.
 - i. Data from Flo Analytics provide ten-year enrollment forecasts for comparison with individual school capacities
 - ii. Enrollment and growth projections differ between the West Linn and Wilsonville portions of the District
 - iii. A member requested a note regarding negative capacity at Rosemont Ridge Middle School and West Linn High School on Table 1, 2023 School Capacity and Enrollment
 - iv. A member requested a graphic that included all District properties, regardless if they are school properties or not
 - v. A member requested language be included to explain the omission of table 6 for 10-Year School Facility Needs in the latest plan due to an enrollment plateau
 - c. Part C: Capital Improvements. Describes the process and criteria used for identifying future capital improvement projects; the link between the LRP and Part II of the LRFP, the Capital Improvement Plan (CIP).
 - i. A member requested a flow chart between the sections of the LRP and the CIP, to illustrate how changes in the LRP are reflected in the final list of projects in the CIP.

 - a. Members discussed the schedule, asked questions and received clarification on timing and process.
 - b. Members agreed to the schedule.
