WAIVER AND RELEASE FROM LIABILITY AND INDEMNITY AGREEMENT

I, the undersigned, sign this Waiver and Release from Liability and Indemnity Agreement (this "Release") for the benefit of The World of Speed Museum, as well as its officers, directors, employees, agents and volunteers ("World of Speed").

In return for participation in student activities at World of Speed, I agree for myself and anyone else who may make a claim for me or on my behalf (collectively, the "Releasing Parties") that:

Medical Consent and Release

World of Speed may secure proper treatment, including medical, surgical, diagnostic, or hospital procedures for the student participating in activities at World of Speed (the "Participant") in the event that an emergency arises and the Participant's parent or guardian cannot be reached. I hereby release and forever discharge World of Speed from any claim whatsoever that arises or may arise on account of any first aid, treatment or service rendered in connection with the Participant's involvement in a World of Speed activity or with any medical decision made by World of Speed.

Liability Release and Indemnification

I and the other Releasing Parties release World of Speed from all liability for damage to property and for all injuries, death, losses, and any other liability incurred by the Participant or any other Releasing Party that arises out of the Participant's participation in any activity at World of Speed. I waive the protection of any applicable statute, the purpose, substance or effect of which is to provide that a general release does not extend to claims that I do not know of or expect to exist when I execute this Release.

Attorney Fees

I agree to pay World of Speed's reasonable attorney fees that it spends to enforce this Release.

Insurance

I represent and warrant that I have adequate insurance to cover any injury or damage that I or any other Releasing Party may suffer while participating in any activity at World of Speed, or else I agree to bear the costs of such injury or damage. I am willing to assume the risk of any medical or physical condition that I or any Releasing Party may have prior to participating in any activity at World of Speed. I understand that World of Speed does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical or disability insurance, in the event of injury or illness.

Photographic and Video Release

For good and valuable consideration, the receipt and sufficiency of which is hereby confirmed, I, the undersigned, individually for myself and for my child, hereby grant to World of Speed, its successors, licensees and assigns ("Company"), the exclusive and irrevocable royalty-free right and license to photograph me and/or my child, record my voice and/or that of my child, reproduce and/or simulate my voice and picture and/or those of my child, and use and/or simulate my name, picture and voice and/or those of my child (the "Likeness") in and in connection with the distribution, exhibition and promotion of the Company and its related media properties, at any time in any media now known or hereinafter derived throughout the universe in perpetuity. This Release supersedes any statement made by or to me in connection with participation in any activity at World of Speed. As used in this Release, each reference to "I," "me," "my," "myself," and other first person references will include any child, ward or other minor for whom I sign. I intend this Release to be enforced to the fullest extent allowed by law.
