	Staff received training around the importance of handwashing in schools. Students will be reminded and encouraged to wash their hands throughout the school day, including designated times to do so.

Cleaning and Disinfection	Cleaning and disinfecting surfaces will follow the guidance from the Centers for Disease Control and Prevention (CDC). The CDC advises that when no people with positive or presumptive COVID-19 cases are known to have been in a space, cleaning once a day is usually enough to sufficiently remove any virus that may be on surfaces and help maintain a healthy facility. District custodians will clean and disinfect health rooms daily. School custodians will also maintain their regular routine cleaning protocols at all school buildings.
Training and Public Health Education	The West Linn-Wilsonville School District provides regular public health reminders and education through district and school newsletters as well as in-person reminders for students. The district works with Clackamas County Public Health to share important health updates or information. The district will communicate with families in the event that additional mitigation strategies need to be implemented. Staff undergo training at the beginning of the school year regarding COVID-19 protocols.

PRACTICING PLAN TO IMPROVE PROCESS

Training exercises are essential to preparedness ensuring individuals understand their role in a communicable disease event. Exercises can also help identify gaps in the planning, thereby building upon and strengthening the plan over time.
