<p>Isolation</p>	<p>The West Linn-Wilsonville School District will require staff or students to isolate for 5 days if they test positive for COVID-19. Face coverings are strongly recommended for the following 5 days upon their return to school.</p>
<p>Symptom Screening</p>	<p>The West Linn-Wilsonville School District will continue to remind staff and families, including volunteers, of the importance of self-screening prior to every school day. If a student is exhibiting visible signs or symptoms of COVID-19, they may be sent to the health room for a screening and/or COVID-19 test with a district nurse.</p>
<p>COVID-19 Testing</p>	<p>The West Linn-Wilsonville School District will continue to offer at-home testing as long as Oregon Health Authority is able to offer it.</p>
<p>Airflow and Circulation</p>	<p>According to ASHRAE (American Society of Heating, Refrigerating and Air-Conditioning Engineers), proper ventilation for prevention of COVID-19 particles requires filters with a rating of MERV 13 or higher. All classrooms in the West Linn-Wilsonville School District have ventilation filters that exceed the MERV 13 rating, with the exception of some select classrooms in the district’s oldest schools. Those classrooms have been equipped with HEPA Filters, which are more efficient than MERV 16 filters.</p> <p>To ensure adequate air flow and ventilation in classrooms, outside air intake has been adjusted to maximize the amount of outside air. Currently, systems are set at 50% outside air, which is adequate to achieve four air changes per hour, more than recommended by ASHRAE.</p> <p>Ventilation is more difficult in large, open spaces such as gymnasiums. In those areas, the district has increased outside air intake as much as outside temperatures will allow. This is in alignment with ASHRAE and Ready Schools, Safe Learners recommendations.</p> <p>Temporary ventilation systems are currently in place at certain school sites while capital bond construction projects wrap up this summer and early fall. Ventilation systems were upgraded at multiple school sites this summer through capital bond projects. Ventilation meets all ASHRAE, OHA, and CDC standards at all schools.</p>

Cohorting	The West Linn-Wilsonville School District will consult the Clackamas County Public Health Department in the event of an outbreak. There are no plans for cohorting at this time.
Physical Distancing	Physical distancing will be encouraged to the extent possible but not required in the school setting. This could include using alternative spaces for meals depending on consultation with Clackamas County Public Health.
Hand Washing	Staff received training around the importance of handwashing in schools. Students will be reminded and encouraged to wash their hands throughout the school day, including designated times to do so.
Cleaning and Disinfection	Cleaning and disinfecting surfaces will follow the guidance from the Centers for Disease Control and Prevention (CDC). The CDC advises that when no people with positive or presumptive COVID-19 cases are known to have been in a space, cleaning once a day is usually enough to sufficiently remove any virus that may be on surfaces and help maintain a healthy facility. District custodians will clean and disinfect health rooms daily. School custodians will also maintain their regular routine cleaning protocols at all school buildings.
Training and Public Health Education	The West Linn-Wilsonville School District provides regular public health reminders and education through district and school newsletters as well as in-person reminders for students. The district works with Clackamas County Public Health to share important health updates or information. The district will communicate with families in the event that additional mitigation strategies need to be implemented. Staff undergo training at the beginning of the school year regarding COVID-19 protocols.

## PRACTICING PLAN TO IMPROVE PROCESS

Training exercises are essential to preparedness ensuring individuals understand their role in a communicable disease event. Exercises can also help identify gaps in the planning, thereby building upon and strengthening the plan over time. Schools, districts, and ESDs should schedule to exercise this plan annually and when any revisions are made to update the plan.
