They are the two behind the kitchen server areas both upstairs and downstairs. Pat wondered if blackout shades should be installed that could be pulled down when needed. Tim shared concern that when kids are in porches they could be seen from anywhere. Tim said we would solve this issue at both locations for these eight unique classrooms. Pat will install blinds. As we hear of unsafe situations, we will address them. (notes archived). May want to apply for safety grants. 5-21-14: Pam is checking on suppliers and options for solving this safety issue. New Safety issues:

1. Paula has a few items to add to the Crisis Flip charts. One involves making a copy of the student's Data Verification Form whenever 911 is called. The other is addressing the steps to take for bloodborne pathogens exposure. Tabled for September.

- 2. How we respond to reports of illness as far as cleaning routines came up as a topic. This will be tabled until September.
- 3. Lock in-Lock out drills need to be done by each school as required by House Bill 2789. This committee needs to emphasize this important safety drill.
- 4. During the summer months, this meeting will take place at 8 am.
