	<ul> <li>9-21-16: Doug received stickers for Wilsonville, but not put up yet. Pat getting work orders with new room numbers.</li> <li>10-19-16: Ongoing process, little left at WHS &amp; ArtTech. Reports of tape covering the new numbers. Tape needs to be removed! District Operations to provide communication out to staff on the importance of these new numbers.</li> </ul>		
15-3.7	<ol> <li>Quarterly Inspections – These are safety inspections at each site.</li> <li>5-18-16: Mark reported that the reports are being done with some challenges.</li> <li>6-15-16: Mark has completed all but the two high schools.</li> <li>7-20-16: Mark has completed all but West Linn High School.</li> <li>9-21-16: Ongoing, working on how to get information to Cindy for website.</li> <li>10-19-16: Toni and Mark reviewed how to track this, Toni to communicate with Cindy</li> </ol>	Mark/Pat	Ongoing
15-4.1	<ol> <li>Intercom System and communication issues in various places in the District.</li> <li>4-20-16: Curt and Tim have discussed this project. How we use this system will be included in the Emergency Management Plan. Maintenance staff, building engineers may also be trained in using this system.</li> <li>5-18-16: Tim reminded the group that we need to talk about how these systems are going to be used. We want to make sure our on site staff are trained to use these systems. When this project is complete, we need to give training and incorporate it into our emergency response plan.</li> <li>6-15-16: Tim reported that Curt is gathering information on any deficiencies in the intercom system.</li> <li>7-20-16: Pat reported that Curt has programed four separate emergency announcements. The announcements are: lockdown, lockout, environmental emergency and weather shelter in place. The same announcement is programed for every building. Mark will ask Curt to implement this in mid-August.</li> <li>9-21-16: We have them, they are all operating. Finding one or two areas that we may need to add another speaker (mostly outdoors). Accessible from any phone. Lockdown, Lockout, Environmental, Evacuate.</li> <li>10-19-16: Schools are practicing drills, still a learning process. Questions include: 'earthquake' vs. 'evacuate'? Call for an Earthquake Drill and go into "Drop, Cover, and Hold" for a minute, evacuate, then take roll. Teachers organize class to follow instructions. In a real emergency, there will be no announcement. Are the buttons synced? Reunification (facilities wouldn't be available)? Hold students on site? Custodial team get certified to check buildings for safety to quicken process?</li> <li>Also: Fire alarm activated and directly following it is a notification to 'evacuate'. New fire code that is required to carry some voice announcement for any new system. 'Evacuate' automated response button should NOT be hit – need to let all secretaries and principals know</li> </ol>	Curt/Tim	Ongoing
16-3 16- 4.1,2,3,4,9	<ul> <li>4. Elert is working with the district on creating a District-wide emergency management plan.</li> <li>a. HB 4075 Statewide School Safety Tip Line will be established</li> <li>b. Surveillance Video Cameras – Management and maintenance</li> <li>c. Radio Communication – Meet standards for communication tools</li> <li>d. GAO Emergency Management – gather info and assist districts</li> <li>e. 	<ul> <li>6-15-16: Elert has turned in draft format for site-specific emergency plans. The Emergency Response Management Steering Committee will be gathered together for a meeting this summer to review these plans. The final draft plan will be sent for review to the District Safety Committee and the Steering Committee.</li> <li>9-21-16: Tim discussed training with Kathy Ludwig. Reunification plans and emergency evacuation plans. Will model plan after the "I Love U, Guys" Foundation Plan. Focus on District wide plans vs. individual school plans for now. On August 16<sup>th</sup> (2) new OARs were instituted: <ul> <li>a) Facilities, Safety, and Emergency Planning (581-024-0275)</li> <li>b) Oregon Healthy &amp; Safe Schools (581-022-2223) – draft</li> </ul> </li> </ul>		
	<ul> <li>due 10/1/16 (submitting this week and posting to website, bring to next meeting), final submitted by 1/1/17</li> <li>Mantadory training by SafeSchools.com – banner offers additional training on emergency management. Goal to implement this training to new administrators (principals for example). GOAL: align Elert, "I Love U, Guys" Foundation, SafeSchools.com, and WLWV to one master document. Finish developing plan. Implement updates to website as "District Safety" with itemized plans/reports/inspections/etc.</li> <li>10-19-16: FEMA published a sample/template for Emergency Management Plans for schools, ours is similar (Homeland Security Management Plan). State level recommends using standardized plan that is crafted with specifications for school/district. Tim and Cindy have Word document to make necessary revisions which will be followed with training/workshop for staff from Elert. Create new Crisis Management Plan packets for classrooms?</li> </ul>		
16-5.2	5. Communication – Pat reported that schools are not consistent in what they use for on-site communication. There are companies that can supply radios for on-site or district wide communication. Tim recommends this discussion take place at a district level. 10-19-16: Pat had a meeting with Day Communication on how we can be ADA Compliant that can be used for district wide communication to within a single school. This project/coordination requires communication with Curt (and training sessions)	Pat McGough	Ongoing
16-5.3	<ul> <li>6. Is there a possibility for eye wash stations in each of our health rooms? Multi-use eye wash bottles have been used but stopped due to the risk of cross contamination. We are investigating the cost of individual eye wash vials but investigating all options. Paula brought this forward with a need for health rooms. Pat suggested she check into the portable units. But, in the health room there is a component that can be attached to the existing sink. We will research this solution. Tim will make sure this is a part of the architect's plan for the two new schools.</li> <li>9-21-16: Paula is looking into the cost of buying the individual snap off vials for more minor situations (in various sizes). No official eye wash stations at this time due to logistics of space and use.</li> <li>Note: discussion of creating a handout for our science teachers for their classrooms.</li> <li>10-19-16: three different sizes to accommodate multiple scenarios. Will use sinks and/or call 911 in the case of a serious emergency</li> </ul>	Pat McGough	Complete
16-6.1	<ul> <li>7. Lead Testing will be done this summer for all water locations in schools.</li> <li>7-20-16: Pat reported that the lead testing has been completed at nine schools. Results from three schools have come back. Six results came back positive, four at Sunset and two at Willamette. Retesting has begun. The results can be found at Oregon Health Authority (OHA), Clackamas County Public Health, and the District website.</li> </ul>	Pat McGough	Complete

	<ul> <li>9-21-16: We have done it everywhere and helped Three Rivers and been to CREST &amp; CREST Farm. Haven't got results from the Admin yet. All schools have been cleared (except one classroom at Cedaroak Park that will remain off until properly fixed). We are correcting <i>every</i> fixture in the district rather than making a temporary fix.</li> <li>10-19-16: Just one test remaining at Oppenlander – we have made all true, permanent corrections</li> </ul>		
16-6.2	<ul> <li>8. Radon Testing will be done by 2021 in every space that can be occupied.</li> <li>7-20-16: Pat reported that Radon Testing plans and protocols have been developed and approved by Oregon Health Authority (OHA).</li> <li>9-21-16: Plan completed and used as model by other districts.</li> <li>10-19-16: Compliant in time, we have until 2021 to test the entire district and scheduling needs to be completed (testing Oct-March)</li> </ul>	Pat McGough	Ongoing
16-7.1	<ul> <li>9. Bond Construction at West Linn and Wilsonville High Schools - what do we have in place to keep the sites secure once school starts in the fall?</li> <li>7-20-16: Officer Finn brought this question forward. Pat reported that he will check in with Bob Teters, Project Manager. A meeting will be held one week before school starts.</li> <li>9-21-16: Lots of work particularly at Sunsetadded two additional IAs to help with crosswalk, playground duty, bus schedules, new exit/evacuation plans. Two cues of busses at WHS. Both high school sites are safe and secure. SROs to check on gates and keep eye on work. Railing to be added on handicap ramps where chain link fencing is.</li> <li>10-19-16: Continue to moniter and bring resources in when necessary (physical or people). Bond devoted additional 21 hours weekly for IA assistance at Sunset.</li> </ul>	Pat McGough	Fall 2016

#### **NEW SAFETY COMMITTEE ISSUES:**

- 1. Would it be efficient to have emergency kits for each classroom in the event that the school went into an emergency lockdown/lockout situation?
- 2. Both high schools need work on their video systems. Hardened glass. Security getting into buildings. Fencing at various campuses. Site circulation (sidewalks and barricades to move traffic better). District Safety Committee motions with the recommendation to add another \$1.5 million to District Safety from 2014 Bond.
- 3. Moved the agreement that drills must be done independently. For example, cannot have a fire drill after an earthquake drill. Must be on separate days to ensure that students and staff are properly understanding and abiding protocols that are in place.
