#### **NEW SAFETY COMMITTEE ISSUES/DISCUSSION:**

1. Radon testing - all schools were required to be tested by January 1, 2021. All locations were completed. New testing needs to be done every 10 years or if there is significant work done on the building. Due to construction six schools will have to be retested. Stafford, Willamette, Cedaroak, and Bolton have all undergone testing due to this construction. Athey Creek and Wood Middle Schools will be done in the fall of 2022. All results will be posted to the District website once available.

Cedaroak, Stafford, Willamette, Bolton have all been tested and no results over the maximum. Wood Middle School and the new Union River HS will be done in the Fall of 2022.

2. The District will hold a reunification walk-through on March 16<sup>th</sup> from 2-4pm. All District personnel with a role in reunification will participate in this event. More details to follow.

**3.** Signs at Rosemont to highlight the cross-walk that goes from the school to the football field. Often times kids are walking through and you cannot tell there is a cross walk.
