20.4-3	<ul> <li>Personal Protection Equipment (PPE)</li> <li>4.21.2021: <ul> <li>The district received a complaint from OSHA questioning PPE and the availability to staff. We have responded and believe the claim will be closed, we have more than enough available (with choices of mask types, face shields, eye protections, etc).</li> </ul> </li> <li>5.19.2021: <ul> <li>Continuing to support staff and facilities supported as needed at the school level.</li> <li>OHA announced yesterday that masks will no longer be required for outdoor athletic activities. The district is ensuring that this is applicable to our sites and will have a formal announcement later today.</li> </ul> </li> <li>6.16.2021: <ul> <li>Regarding the announcement in changes in protocols – once this school year ends and summer session begins, protocols will change to align with RSSL effective June 24<sup>th</sup>. Dropping the requirement for face coverings outdoors. Plastic barriers will be removed. Dialing back on the cleaning requirements (everything will still be disinfected, but not at the frequency that we have done this year). Protocols for the fall have not been defined yet.</li> <li>Ordered 1000 new desks to accommodate the new desk requirements for 3' distancing requirements (which really comes out to about 4' distancing).</li> </ul> </li> </ul>		
21.5.1	<ul> <li>Drills:</li> <li>5.19.2021: <ul> <li>We know that this year is different and there are twice as many drills due to cohorts, but we need staff to be taking the emergency response protocols (lockout, lockdown) drills more seriously.</li> <li>Perhaps consider more diverse scheduling requirements for next year? Less notice to staff?</li> </ul> </li> <li>6.16.2021: <ul> <li>Only a few more drills left!</li> </ul> </li> </ul>
