Two are not related to school buildings (WLHS stadium + parking, storage facility Stafford River property). Newer systems are slower to lock the doors. Few punchlist items remaining.</li> </ul> <p><b>5.19.2021:</b></p> <ul style="list-style-type: none"> <li>Still continuing to have some issues but working it out with contractors and they will be rolling out a more intentional performance design.</li> </ul> <p><b>6.16.2021:</b></p> <ul style="list-style-type: none"> <li>See notes on bond. Continue contact tracing. 20.4-3	<p><b>Personal Protection Equipment (PPE)</b></p> <p><b>4.21.2021:</b></p> <ul style="list-style-type: none"> <li>The district received a complaint from OSHA questioning PPE and the availability to staff. We have responded and believe the claim will be closed, we have more than enough available (with choices of mask types, face shields, eye protections, etc).</li> </ul> <p><b>5.19.2021:</b></p> <ul style="list-style-type: none"> <li>Continuing to support staff and facilities supported as needed at the school level.</li> <li>OHA announced yesterday that masks will no longer be required for outdoor athletic activities. The district is ensuring that this is applicable to our sites and will have a formal announcement later today.</li> </ul> <p><b>6.16.2021:</b></p> <ul style="list-style-type: none"> <li>Regarding the announcement in changes in protocols – once this school year ends and summer session begins, protocols will change to align with RSSL effective June 24<sup>th</sup>. Dropping the requirement for face coverings outdoors. Plastic barriers will be removed. Dialing back on the cleaning requirements (everything will still be disinfected, but not at the frequency that we have done this year). Protocols for the fall have not been defined yet.</li> </ul>		

	<ul style="list-style-type: none"> <li>Ordered 1000 new desks to accommodate the new desk requirements for 3' distancing requirements (which really comes out to about 4' distancing).</li> </ul> <p><b>7.9.2021:</b></p> <ul style="list-style-type: none"> <li>No update at this time.</li> </ul> <p><b>9.15.2021:</b></p> <ul style="list-style-type: none"> <li></li> </ul>		
21.5.1	<p><b>Drills</b></p> <p><b>5.19.2021:</b></p> <ul style="list-style-type: none"> <li>We know that this year is different and there are twice as many drills due to cohorts, but we need staff to be taking the emergency response protocols (lockout, lockdown) drills more seriously.</li> <li>Perhaps consider more diverse scheduling requirements for next year? Less notice to staff?</li> </ul> <p><b>6.16.2021:</b></p> <ul style="list-style-type: none"> <li>Only a few more drills left!</li> </ul> <p><b>7.9.2021:</b></p> <ul style="list-style-type: none"> <li>All drills for the school year are complete.</li> </ul> <p><b>9.15.2021:</b></p> <ul style="list-style-type: none"> <li></li> </ul>		
21-7.1	<p><b>Ready Schools Safe Learners (RSSL)</b></p> <p><b>7.9.2021:</b></p> <ul style="list-style-type: none"> <li>The DRAFT document for Covid-19 mitigation for the 2021/2022 school year was presented to the committee for review and comment. Some members were concerned about physical distancing and face coverings, but understood that the RSSL has made changes from requirements to strongly advising these protocols. Another concern expressed is the possible need for additional space with health rooms should a student need to be isolated. The Maintenance Department will work with principals to identify additional spaces as needed.</li> <li>This meeting replaces the District Safety Meeting on July 21, 2021.</li> </ul> <p><b>9.15.2021:</b></p> <ul style="list-style-type: none"> <li></li> </ul>
